Open communication is very important to me and my staff, and I strive to provide you with the most accurate information possible about things that are happening in District 10. This is why I want to take a minute to address some inaccurate information that has been circulating throughout the community.

The first is about the possibility of a Wendy's Drive-Thru being built on the old Shell Gas Station property at the southwest corner of Almaden Expressway and Redmond Avenue. As of now, there have been no permit requests for any sort of project at this location, let alone a fast-food restaurant. In fact, the property is not zoned for that kind of development and any rezoning would need to go to the City Council for consideration.

The second, and one that has been a topic of discussion for quite a while, is the Via Valiente Shopping Center. My staff has been in touch with both the property manager and the property owner. The contractor has started preparations to repair the damaged support at CVS, and they have applied for a building permit to make the necessary repairs. The owner anticipates that the repairs will be completed soon – hopefully within the next couple of weeks. The owner also continues to seek out possible tenants for the former PW space and, in the meantime, has welcomed a new, twice-weekly farmer's market to the Center's parking lot to help enliven the space.

The third is the possibility of an amphitheater or concert venue coming to Almaden Lake Park. This was never a part of any of the conceptual alternatives that the Water District is considering, and such a project is not included in any of the feasible alternatives. On March 13th, the District provided the latest information about plans for the lake, along with possible changes to the alternatives they are considering. In a district like ours, where residents are involved and engaged, communication is an asset and a treasure. We continue to update the website, as well – for example, you can now view past newsletters or check out photos from recent events at the [Newsroom](#) tab.

This past week, I voted on several important issues facing our city that came before the City Council. The first was a proposal to provide funding for two sessions of the Police Academy each year for up to four years. I am happy to announce that this request passed unanimously. The City can train up to 60 police recruits in each of these academies, putting up to 120 new police officers on the street each year. These academies are essential to helping us to rebuild capacity in our police department that has been reduced through budget cuts, retirements, and resignations over the past few years.

Next, two of my colleagues on the City Council, Pierluigi Oliverio and Pete Constant, joined me in opposing having the City support State Senate Bill (SB) 391 that would impose a new \$75 fee on all property-related filings (except those already subject to transfer tax). Including this fee, there are 12 different tax and fee increases currently working their way through the State legislature and the City is also considering its own new taxes to fund transportation. In addition, soon my colleagues and I will debate whether or not to move forward with exploring a “Housing Impact Fee” that would be imposed locally to raise money for the same purpose as SB 391 – affordable housing. With state and county sales taxes and state and federal income taxes on the rise and the cost of living beginning to creep upward, I do not think the City should be actively promoting new taxes at the State level over which there will likely be no local control and accountability. I want to be sure that San Jose remains an affordable place to live, work, play, and raise a family.

Finally, an issue before the City Council that received quite a bit of media attention was the approval of incentives from the City and the State of California for Samsung Semiconductor to redevelop and expand their 300,000 sf headquarters at North First Street and to develop its proposed Research and Development (R&D) Center here. This also passed unanimously. The incentives offered by the City include expedited permitting, a utility user tax rebate, a traffic impact fee reduction, and a \$500,000 reimbursement for eligible equipment purchased. Samsung, which currently employs about 300 people in San Jose, will be able to grow their workforce to 2,000 once their

new, architecturally-significant Americas Headquarters is completed here in San Jose.

The tax and fee reductions, together with the \$500,000 equipment reimbursement, will total approximately \$7 million over ten years, but the project will generate about \$23 million in new revenues that will benefit the city.

This vote continues San Jose's commitment to generating jobs and supporting private-sector R&D and manufacturing growth. Thank you, Samsung, for choosing San Jose for your growth and expansion!

## Collection Day Lookup Now Includes Neighborhood Cleanup Dates

San José's online Collection Day Lookup now provides a convenient way for residents to find their neighborhood cleanup event date. By entering their street number and zip code into the online form at [www.sanjoseca.gov/lookup](http://www.sanjoseca.gov/lookup), residents can find their cleanup date, as well as garbage, recycling, and yard trimmings collection day, street sweeping schedule, and service provider contact information. Any resident who is unable to use the online tool may call the Customer Contact Center for assistance at (408) 535-3500. Cleanup events are scheduled once every three years, and notices will continue to be mailed in advance. They are popular with residents for disposing of rubbish, metal, construction debris, mattresses, tires, old appliances and other items that are not collected through the weekly residential garbage collection service. The Collection Day Lookup was created by the Environmental Services Department in partnership with Planning, Building and Code Enforcement and Information Technology.
