## **CITY COUNCIL PUBLIC HEARINGS SET BY CITY CLERK**

### HEARING DATE

- a. The Planning Commission and City Council is scheduled to consider a General Plan text amendment, amendments to the North San José Area Development Policy, and amendments and additions to Title 20 (Zoning Code) of the San José Municipal Code as described below.

Proposed Project: To further the goals and policies of the Envision San José 2040 General Plan and support implementation of the North José Area Development Policy, the project proposes the following:

1. City-initiated General Plan Text Amendment to revise the Industrial Park land use designation to allow additional flexibility for retail uses consistent with area plans and policies;
2. Amendments to the North San José Area Development Policy to allow additional flexibility for local serving commercial uses that meet certain criteria; and
3. Amendments to the Zoning Code to add provisions to allow stand-alone commercial support uses in the IP Industrial Park Zoning District within the North San José Development Policy area that meet certain criteria and are consistent with the North San José Area Development Policy.

CEQA: Determination of Consistency with the Final Program Environmental Impact Report for the Diridon Station Area Plan (Resolution No. 77096), the Final Program Environmental Impact Report for the Envision San José 2040 General Plan (Resolution No. 76041) and the Envision San Jose 2040 General Plan Supplemental Environmental Impact Report (Resolution 77617) and Addenda thereto.
