## **CITY COUNCIL PUBLIC HEARINGS SET BY CITY CLERK**

### HEARING DATE

- a. Consideration of a Site Development Permit to allow for the demolition of Parkside Hall to allow the construction of a 24 story mixed-use development with approximately 19,000 square feet of ground floor retail, approximately 214,000 square feet of office, approximately 60,000 square feet of museum space, 184 hotel rooms, and 306 residential units, the removal of 20 ordinance-sized trees, and a Special Use Permit and a Vesting Tentative Map to reconfigure 25 parcels into three legal parcels, and to create 306 residential condominium units and 244 commercial condominium units on Parcel 1, an approximately 2.5 gross acre site, located on the northwest corner of West San Carlos Street and South Market Street (180 Park Avenue) (City of San Jose, Owner). CEQA: Supplemental Environmental Impact Report for the Museum Place Mixed-Use Project to the: 1) "The Downtown Strategy 2000 Final Program Environmental Impact Report," adopted by City Council Resolution No. 72767 on June 21, 2005; 2) "Envision San José 2040 General Plan Final Program Environmental Impact Report," adopted by City Council Resolution No. 76041 on November 1, 2011; and 3) "Supplemental Environmental Impact Report to the Envision San José 2040 General Plan Final Program Environmental Impact Report," adopted by City Council Resolution No. 77617 on December 15, 2015.
