Dear Neighbor,

It is hard to believe that summer vacation has come to a close and the kids are back to school. I wish all of our students, teachers, administrators, support staff, coaches, and parents a safe and fruitful school year! When taking office, I was told that things usually slow down a bit during the summer months, but my office has been busier than ever organizing events, assisting constituents, and looking for innovative ways to make District 10 and our City an even better place to live.

NATIONAL NIGHT OUT

On August 6th, several neighborhoods in District 10 hosted National Night Out events. I had the pleasure of attending several of these functions, and each one was unique. In Almaden, I visited a few quaint, block party-style gatherings, with neighbors coming together to share stories, food, and drinks. In the Playa Del Rey neighborhood, Bob Vonderwerth and Richard Lazarowich hosted a fantastic event with a steady crowd of about 75 people throughout the night, enjoying popcorn and snow cones and the company of their neighbors. I was joined there by Johnny Gogo from the Santa Clara County District Attorney's office, and representatives from Assemblymember Paul Fong's and Senator Jim Beall's offices.





The largest gathering in San Jose was the National Night Out event for the Hoffman-Via Monte Neighborhood. Like I stated in my last newsletter, I was very excited that this event was one of only four in the nation to be sponsored by Target Corp. I anticipated great things for this event, and my expectations were greatly exceeded. With appearances by Gigante from the San Jose Giants, Q from the Earthquakes, and Bulls Eye from Target, it is no wonder there were over 600 people in attendance. We gave away more than 300 backpacks, stuffed full of school supplies, to neighborhood children. Another highlight was when Target presented Acting Police Chief Larry Esquivel with a donation of \$3500 toward the SJPD's Crime Prevention Unit.

With such a phenomenal event, I must extend my sincere appreciation and gratitude to all of those who made it happen. Thank you to lead sponsor Target Corp., Cornerstone Community Church, Almaden Hills United Methodist Church, South Valley YMCA, and Neighborhood Housing Services of Silicon Valley for sponsoring the event. I am optimistic that we made a positive impact in the neighborhood and I look forward to more opportunities such as these; bringing people together, making our neighborhoods safe, and working together for the good of all.

REDUCING THE COST OF HOME IMPROVEMENTS

Last Tuesday was the first Council meeting of the new Fiscal Year and we had a full agenda. The next day, at a meeting of the Rules and Open Government Committee, I presented a memo in regard to permitting fees for small home remodeling projects. The memo was approved by the Rules Committee for a hearing by the whole City Council as part of our Council Priority Setting Session in early September.

In researching the permitting costs associated with a \$30,000 home addition project, I was shocked to learn that they would total over \$5,000, or 20% of the cost of the actual construction work! For many homeowners, these high costs can mean the difference between moving ahead with a project or foregoing the project altogether. What's worse, is that many homeowners may move forward with projects without the proper permitting and inspections, running the risk of shoddy or substandard construction that does not conform to the safety elements of the current building code.

At present, the permits for these single-family home improvement projects absorb a full pro-rata share of executive and managerial overheads, even though very little executive or managerial time is spent on these relatively small remodels. In addition, the Construction and Conveyance Tax imposed is assessed the same as it is for much larger projects, even though a small bathroom remodel would typically have no impact on, for example, streets within the City.

By developing a "second tier" fee structure for small, single-family, residential improvement projects, we can save homeowners money while at the same time improving the City's housing stock, improving compliance with City code, generating additional general fund property tax revenue, and providing additional work to small businesses within San Jose while creating good-paying jobs in the construction sector. This is a win-win-win-win for homeowners, the City, small business, and job seekers.

MARTIAL COTTLE PARK GROUNDBREAKING

I was thrilled to attend the Martial Cottle Park Groundbreaking Ceremony on August 9th. Martial Cottle Park is a beautiful jewel in District 10 and the City. In 2004, Mr. Walter Cottle Lester donated the 287.54-acre Martial Cottle Park property in South San Jose to the Santa Clara County Parks and Recreation Department and the CA State Parks Department. This new park will be an exciting opportunity for the community to become involved with the County Parks and Recreation Department and CA State Parks in the planning process. While it is a County Park, the City of San Jose has been granted an area for a Community Garden, the first in District 10. Construction is underway for the perimeter trail and other phase one projects.



REMEMBERING BOB COELHO

Bob Coelho, a long-time Almaden resident, passed away on August 10th. Bob was a

community leader and volunteer with a heart to help and make a difference. I had the pleasure of serving alongside Bob in the Almaden Kiwanis and Almaden Cares. Notably, he was a founding member of both organizations. Bob was instrumental in starting the Champs Foundation with Ned Hales and members of the San Francisco 49ers, helping underprivileged youth attend summer camp. In addition, Bob was a long time coach of basketball and baseball in Almaden. I am honored to know him and I will miss him dearly. I send my deepest condolences and prayers to his wife, Gretchen, and the rest of Bob's family.

Business Tax Amnesty Program Deadline Extended

The Business Tax and Business Improvement District Amnesty Program began on December 1, 2012, and are now set to expire on August 30th, 2013. The amnesty forgives penalties and interest on past-due business taxes and BID assessments for the current year an up to three prior years. The amnesty covers the tax delinquency period of January 1, 2009 through December 31, 2012. As of July 20, 2013, the Business Tax

Amnesty Program had generated approximately \$2.7 million of revenue.

Almaden Lake Proposed Alternatives Meeting

The Santa Clara Valley Water District will update the community on the progress of its work on Almaden Lake on Thursday, September 5th from 6:30 p.m. to 8:00 p.m. at the Almaden Community Center, 6445 Camden Ave, San José. The project team will review the hydraulic analysis for the restored creek connection and address the ongoing oxygenation pilot project at the Calero and Stevens Creek reservoirs that could determine new alternatives for addressing methyl mercury contamination at the lake. Given that the room can accommodate only 200 people, please be sure to RSVP by email to tmercado@valleywater.org or phone at 408-630-2342. The water district will schedule another meeting, if necessary, to accommodate high levels of interest.

Residents living near Almaden lake have spearheaded the Save Almaden Lake initiative. They are playing an important role in bringing information about the Water District's plans for Almaden Lake to the public's attention.
