I know this is not my typical opening greeting, but I am fed up. I am tired of seeing our beautiful city become the canvas for criminals to mark their territory. That is why my staff and I have been working on several projects to not only abate the graffiti in our neighborhoods, but, hopefully, to prevent it from happening again.

I am sure you are all aware of the broken windows theory. If not, it basically states the longer blight remains in a location, it helps precipitate more blight and other crimes. Well, I don't want that for District 10, so my office has planned several painting restoration projects in District 10. One of those is coming up on April 26th. For the Great American Litter Pick Up, we will be painting one of those highly-tagged areas of our community. My office has partnered with the Anti-Graffiti and Litter Program, splitting the cost of the paint, to restore the sound wall along Almaden Road between Kelez and Trinidad. This is a VERY long stretch of wall and we will need an army of volunteers to help us paint the entire thing, so please consider joining us to help beautify and restore this area. # **GREAT AMERICAN LITTER PICK UP**

Like I just mentioned, it's that time of year again! Time to put on your gloves and grab your pick-up sticks, because the Great American Litter Pick Up is just around the corner! On Saturday, April 26th, from 8:00 AM - 1:00 PM, my office will be organizing litter pick-up and beautification projects all around District 10! This is a wonderful opportunity to get out and help beautify your neighborhood while getting to know your neighbors. This is also a great opportunity for students looking for community service hours!

Last year, we increased our volunteer numbers 10-fold from the previous year, and we are hoping for record-breaking numbers of volunteers on April 26th! With staging areas

all around District 10, we have made it convenient for almost every neighborhood to find a spot to volunteer that is near their home and directly helps their community. Below you will find the five staging areas around the District, with the details of the sorts of projects we will be working on:

### Staging Site Number 1: Almaden Community Center

-At the Almaden Community Center, volunteers will be pulling weeds, picking up trash and spreading wood chips around the center campus. With large flower beds and lots of shrubbery, we want to ensure that the Almaden Community Center remains a clean and welcoming place for everyone to enjoy. If you plan to volunteer at this location, please be bring your own gardening gloves, shovels, and rakes.

Staging Site Number 2: Almaden Road sound wall – between Trinidad and Kelez -Unfortunately, the Almaden Road sound wall has been plagued by tagging of all sorts. Luckily, we have a diligent volunteer who has been painting over the graffiti when it happens, but now the wall is left with splotches of different shades of paint. We need A LOT of volunteers to help us restore this wall! We want to make sure the wall is one, uniform color and that all signs of tagging are removed. If you plan on volunteering here, please wear clothes you wouldn't mind getting paint on.

## Staging Site Number 3: Pioneer High School – Hoffman-Via Monte

-The Hoffman-Via Monte neighborhood has been a hot spot for graffiti and litter. Last year, we collected more bags of trash from this neighborhood than all of the other sites combined. We want to make sure we keep this neighborhood clean and a priority for litter pick up. We will also be working on graffiti removal from public areas. We will be meeting in Pioneer High School's back parking lot and walking over to the neighboring Hoffman-Via Monte community.

### Staging Site Number 4: Playa Del Rey Park

-This is a new site this year, and we are looking forward to working in this neighborhood. Volunteers will be doing general litter pick up, graffiti removal, and cleaning of park amenities, as well as a possible tree planting. We hope to see a lot of the Playa Del Rey neighbors help with this clean up effort!

# Staging Site Number 5: Del Roble Elementary School

-This is also a new site this year! District 10 staff members have been coordinating with the principal of Del Roble to ensure that this event is a success. Similar to Playa Del Rey, volunteers will be doing general litter pick up. We are hoping to get families from the school involved, and teach kids the importance of volunteerism and community involvement!

## Staging Site Number 6: Ohlone/Chynoweth VTA Station

Since a great team of volunteers will be sprucing up Vista Park last weekend, we will be focusing our efforts in a different section of the VEP neighborhood this year. Volunteers can choose from several different projects here; general litter pick up, graffiti removal, and tree and shrub trimming and removal along nearby trails. This is also a great opportunity for students from Gunderson High School to earn community service hours while beautifying the area around their school.


In order to make this event a success, we need your help! This entire event depends on volunteers from our community. Breakfast snacks, coffee, and lunch will be provided for

Although 2014 is a major Congressional election year, there was a great deal of optimism expressed by members of Congress about the opportunity for agreement on some of these key issues. Given that it is an election year, there is no better time for citizens to be engaged in our democratic process and to hold our federal representatives accountable for whether or not they make progress on the legislative priorities of our City and its residents.

Last year during the budget process, I drafted a Budget Document to transfer up to \$3,500 of my office budget to PRNS for the acquisition and installation of the hardware required to expand wireless internet access throughout the Almaden Community Center and Library. Key areas of the Community Center, including various meeting rooms, lacked the WiFi signal necessary for user access. I am very happy to announce that the wireless system has been installed and those areas previously without signal are now enabled with WiFi! Thank you to the Almaden Community Center Staff and the IT Department for getting it the expanded service up and running!

#### GUEST COLUMN FROM SCVWD BOARD MEMBER LINDA LEZOTTE

Please read the following letter below from Santa Clara Valley Water District Board Member, Linda LeZotte, regarding the drought situation facing our region.

"I recently spoke to the Campbell Chamber of Commerce about the severe drought and the how the Santa Clara Valley Water District is dealing with this situation. I wanted to share that information with you. In late February, as a member of the Board of the Water District, my colleagues and I passed a resolution calling upon retail water agencies, the county and local cities to implement mandatory measures to reach a water use reduction target equal to 20 percent of 2013 water use. Despite a few recent storms, our water supply conditions still look bleak. Locally, our reservoirs are only at about half of their normal capacity for this time of year.

We called for mandatory conservation due to significant changes between late January and late February. One, a reduction of the amount of water imported from the Sierra Nevada watersheds through the Sacramento-San Joaquin River Delta to our county. On Jan. 31, the state Department of Water Resources reduced our allocation from 5 percent of the district's contract amount to zero. This impacts the district's ability to transfer water that has been stored underground near Bakersfield to supplement our Santa Clara Valley aguifer.

Two, on Feb. 21, the U.S. Bureau of Reclamation announced that the water district's agricultural allocation would be zero, and our allocation for use by homes and businesses would be reduced to 50 percent of historic use. These reductions will require the District to implement aggressive water management techniques.

A priority of the district is continued delivery of safe, clean water from its drinking water treatment plants to retail water agencies, the county and local cities. Imported water typically provides more than 85 percent of the supply for the water district's three drinking water treatment plants. In dry and critically dry years, when local water is limited, up to 99 percent of treated drinking water is from imported water sources. With less fresh water flowing through the Delta, the district is working with retail water agencies to maintain our normally high drinking water quality.

Because of the lack of local and imported water, nearly all of our groundwater replenishment operations have been cut back to conserve supplies for use this summer. This means most of our groundwater recharge ponds around the county are beginning to dry or are already dry, despite recent rainfall.

We've also begun storing imported water in Anderson Reservoir to help ensure that there is sufficient water to supply treatment plants through the year.

Residents and businesses can expect over the coming weeks, for their local water provider or municipality to begin implementing measures to reach the 20 percent target. The water district, as a wholesale provider, relies on retailer water agencies, local municipalities and the county to enact and implement local ordinances and water use reduction measures.

The Board has also established an Ad Hoc Water Conservation Committee to discuss the implementation of actions to achieve the district's water use reduction targets.

We all know that water use efficiency is always the right thing to do. In this drought, immediate

conservation will help ensure that our community has enough water to meet essential needs.

The water district has developed a one-stop website for information about water supply conditions, conservation programs, water saving tips and drought alerts. ### **UPCOMING DISTRICT 10 PROJECTS - PUBLIC HEARINGS**

On Wednesday, April 9th, at 6:30 PM, the Planning Commission will take up two District 10 matters. The first is a zoning change to allow for the construction of ten single-family homes on privately-owned property, currently zoned for residential use, located on the west side of Almaden Expressway at the southern terminus of Brasilia Way. The developer has owned this property for several years.

The 2040 General Plan calls for residential zoning of this property to allow for up to approximately 15 single-family, detached homes. The developer, after much input from the City Planning Department and from residents, including at two community meetings, has proposed a 10-home project that minimizes visual effects on surrounding neighborhoods and preserves a majority of the acreage in its natural state.

The second project is a Conditional Use Permit to allow for renovations, remodeling, and an addition at the Almaden Golf and Country Club. The Club held a community meeting previously to hear input from the community and neighborhood concerns.

All are welcome to attend and speak on these projects. The meetings are held within the City Council Chambers at City Hall, 200 E. Santa Clara St., San Jose, CA 95113.

# **Lawn Mower Exchange Program**

Older gasoline lawn mowers can have a significant impact on air quality. To reduce air

pollution, the Air District is providing a rebate towards the purchase of a new, cordless, zero-emission electric lawn mower after turning in your operable gasoline lawn mower for recycling. The Air District invites you to participate in the program and to share this information with other Bay Area residents that may be interested in participating in this program.

Three lawn mower exchange events will be held from 8:00 AM - 2:00 PM on the following dates:

- March 22nd, in Novato, at the College of Marin, Indian Valley Campus
- April 5th, in Saratoga, at West Valley College
- April 26th, in Oakland, at the Oakland International Airport

The program will provide incentives for up to 2,400 lawn mower exchanges. Bay Area residents will be able to trade-in their old gas mower and select from two Black & Decker cordless battery electric lawn mowers at a discounted price. Both electric lawn mowers have a 30-day manufacturer satisfaction guarantee and two-year warranties. The two lawn mowers that will be available for purchase at the discounted price are:

- Black & Decker (CM 1836) 18-Inch Cordless for \$110 (normally up to \$350)
- Black & Decker (CM 1936) 19-Inch Cordless for \$190 (normally up to \$400)

Advance registration is required and you must be a Bay Area resident in order to participate.
