### **GREAT AMERICAN LITTER PICK UP**

The Great American Litter Pick Up is just around the corner! On Saturday, April 26th, from 8:00 AM - 1:00 PM, my office will be organizing litter pick-up and beautification projects all around District 10! This is a wonderful opportunity to get out and help beautify your neighborhood while getting to know your neighbors. This is also a great opportunity for students looking for community service hours!

Last year, we increased our volunteer numbers 10-fold from the previous year, and we are hoping for record-breaking numbers of volunteers on April 26th! With staging areas throughout District 10, we have made it convenient for almost every neighborhood to find a spot to volunteer that is near their homes and directly helps their community. Below you will find the six staging areas around the District, with the details of the types of projects we will be working on:

#### ***Staging Site Number 1: Almaden Community Center***

-At the Almaden Community Center, volunteers will be pulling weeds, picking up trash and spreading wood chips around the center campus. With large flower beds and lots of shrubbery, we want to ensure that the Almaden Community Center remains a clean and welcoming place for everyone to enjoy. If you plan to volunteer at this location, please bring your own gardening gloves, shovels, and rakes.

#### ***Staging Site Number 2: Almaden Road sound wall – between Bose Lane and Kelez***

-Unfortunately, the Almaden Road sound wall has been plagued by tagging of all sorts.

Luckily, we have a diligent volunteer who has been painting over the graffiti when it happens, but now the wall is left with splotches of different shades of paint. We need A LOT of volunteers to help us restore this wall! We want to make sure the wall is one, uniform color and that all signs of tagging are removed. If you plan on volunteering here, please wear clothes you wouldn't mind getting paint on.

***Staging Site Number 3: Pioneer High School – Hoffman-Via Monte***

-The Hoffman-Via Monte neighborhood has been a hot spot for graffiti and litter. Last year, we collected more bags of trash from this neighborhood than all of the other sites combined. We want to make sure we keep this neighborhood clean and a priority for litter pick up. We will also be working on graffiti removal from public areas. We will be meeting in Pioneer High School's back parking lot and walking over to the neighboring Hoffman-Via Monte community.

***Staging Site Number 4: Playa Del Rey Park***

-This is a new site this year, and we are looking forward to working in this neighborhood. Volunteers will be doing general litter pick up, graffiti removal, and cleaning of park amenities, as well as a possible tree planting. We hope to see a lot of the Playa Del Rey neighbors help with this clean up effort!

***Staging Site Number 5: Del Roble Elementary School***

-This is also a new site this year! District 10 staff members have been coordinating with the principal of Del Roble to ensure that this event is a success. Similar to Playa Del Rey, volunteers will be doing general litter pick up. We are hoping to get families from the school involved, and teach kids the importance of volunteerism and community involvement!

***Staging Site Number 6: Ohlone/Chynoweth VTA Station***

-Volunteers can choose from several different projects here; general litter pick-up, graffiti removal, and tree and shrub trimming and removal along nearby trails. This is also a great opportunity for students from Gunderson High School to earn community service hours while beautifying the area around their school.

In order to make this event a success, we need your help! This entire event depends on volunteers from our community. Breakfast snacks, coffee, and lunch will be provided for all who help out, and volunteer service hours will be given to students who need them. **ALMADEN RANCH DEVELOPMENT**

Driving along Almaden Expressway, many of you may have seen the construction on the large parcel of land at the intersection of Almaden Expressway and Highway 85, across from the Best Buy shopping center. This development is called Almaden Ranch and is the future site of a Bass Pro Shop. While the development is in District 9, not District 10, it will certainly affect the traffic in our neighborhoods and my office often receives calls and emails regarding the project.

Recently, representatives from both the developer and the property manager of the Almaden Ranch retail center project spoke at both the VEP Neighborhood Association

and the Erikson Neighborhood Association. Below is information from their newsletters about the presentations.

*As the project details firm up, there have been minor site changes for which a Planned Development permit amendment was filed in December. The Bass Pro Shop will have a lodge look with a water feature in front, and include an Uncle Buck's restaurant inside. Bass Pro will build boats to order in their store. They plan to have a boat hull storage lot on the northeast side of the property between Cherry Ave and the Guadalupe River, but no work will be done there.*

*They are in the process of requesting permission for a height exception to allow an 80 foot tall design feature in a specific location, about 30 ft x 30 ft, in the back of the property behind Bass Pro Shop. This would extend about 15 ft above the freeway at that point.*

*Some other tenants are expected to include a PGA Superstore, City Sports Health Club, Ulta Cosmetics and about 3-4 unique restaurants. They are also considering a future hotel at the southeast portion of the property. That would be a separate project and require separate approvals later.*

*Current construction is all infrastructure related. They hope to begin facilities construction this summer for completion by about March-June next year. They anticipate opening the Cherry/Sanchez connection to the public about the same time.*

*Both the developer and City Council District 9 have provided the money needed to build a pedestrian bridge across Guadalupe River. This will allow pedestrian/bike traffic to access Oakridge Shopping Center and the VTA Light Rail.*

### **BRASILIA WAY - GUEST COLUMN FROM COLIN GRAY - JSM ENTERPRISES**

Below is a guest column from Colin Gray, the Senior Vice President of JSM Enterprises, the developer of the Brasilia Way project.

*When the Envision 2040 Plan was developed, the City of San Jose conducted extensive community outreach and spent a great deal of time and energy to review its development policies and identify areas throughout San Jose where future development would occur. During this process, the 7-acre parcel at the end of Brasilia Way, near the intersection of Coleman Avenue and Almaden Expressway, was designated in the General Plan as Rural Residential with the potential of developing up to two homes per acre (a maximum of about 14 homes) on the site. This designation was carefully considered by City stakeholders and approved by the City Council, along with the new*

*General Plan, on November 1, 2011. With this in mind, JSM Enterprises has developed a proposal that provides the City with over five (5) acres of open space, dedicated as open space in perpetuity via an easement, while working to minimize the loss of native oak trees and delivering ten (10) carefully-planned, beautiful homes for the residents of Almaden Valley.*

*The site is a very significant site within Almaden and we were tasked with working with neighbors, the City of San Jose Planning Department, and the City Council to develop a plan that will create a viable development that carefully minimizes visual and other environmental impacts while supplying much-needed homes to a growing population. The top of the hill was previously developed as a ranch-style home with a detached garage/shop and a large, nearly one-acre, paved area. Some grading had also been done on the eastern side of the property and elsewhere on the property, areas that are devoid of trees.*

*After two community meetings, as well as several private meetings with neighbors, it was determined that the effects on trees, the view-shed, and the natural hill were three of the biggest concerns. To minimize the visual impacts, we worked carefully to cluster five homes at the site of the existing home site and located them such that the residents will see only one or two, depending on their view of the site. These views will be screened by the planting of 8-to-10-foot native oak trees. The homes are also set within existing oaks, which become a masking element to lessen the visual impact and help maintain the beauty of the hill. Further, these homes utilize smaller lots and no back yards, paired with carefully-designed outdoor entertaining spaces that maximize the views of the existing landscape and limit disturbing the natural aesthetic of the hill. Homes will not have fenced yards. The remaining five homes are placed along Almaden Expressway, at the bottom of the hill. The area's existing 8-foot sound wall will be continued along the frontage to provide a sound barrier for new and existing residents, while still affording views of the beautiful oak trees at the top of the hill and the attractive homes along Almaden Expressway.*

*The site currently has 55 native oak trees varying in size, age, and health. This project will preserve a minimum of 43 of these native oaks. We will also plant 35 new native oaks on-site. The newly-planted trees will help hide the new homes and to provide an excellent resource to our Urban Forest. They will be a mixture of 48" box trees and field-grown trees that will be carefully tended to insure their survival. They will not be seedlings or small 24" box trees. These larger oaks (8-10 feet tall) provide an immediate visual impact. The loss of any of the existing trees is not taken lightly. In fact, the majority of the time spent designing this project was spent avoiding the disturbance of the existing trees. However, when developing an in-fill site, there are sometimes trees that cannot be saved. Two of the trees are actually touching the existing driveway and, when it is improved, they will not survive. Others are being removed due to various reasons; however, we are working with City staff to make every effort to preserve as many trees as possible. Further, the 35 new oaks will mature and result in a net gain of 23 native oak trees on the property.*

*JSM Enterprises takes its responsibility to the environment and the neighbors very seriously. Every effort has been made, and will continue to be made, to produce a thoughtfully-executed and beautiful product. If approved, this project will provide the residents of San Jose with over 5-acres of permanent hillside open space, add 23 new oak trees and provide 10 beautiful homes to meet the city's demand for quality housing.*

## **HR 29**

Recently, the State Assembly introduced House Resolution 29, a piece of legislation that could potentially harm the state of our City's finances. The resolution states that the Assembly opposes the "outsourcing of public services and assets, which harms transparency, accountability, shared prosperity, and competition." In a report from our city manager, the impacts noted are as follows:

-HR29 is aimed at restricting local government's ability to manage its very mission to provide local services in an efficient and economical way.

-HR29 attempts to lock legislators into a vote without specific, real details required to make an informed decision.

-HR29 would deny local government the flexibility to determine how to deliver quality services to its residents.

-HR 29 is unfavorable for California's business climate.

According to the City Manager, "the legislation would unduly interfere with the City's ability to explore alternative, cost-effective options in providing efficient, quality services to its residents which, ultimately, is the City's primary purpose." As of April 9th, over 40 California cities have stood in opposition of this resolution. I would encourage you to share your opinions regarding the resolution to your State representatives. - Agree to complete Election Officer training
- Agree to work on Election Day
