The City of San José Planning Division invites you to a community meeting about a proposed development in your area at 389 East Santa Clara Street (see map on reverse side).

**Project Proposal:** Our Lady of La Vang Parish submitted a Special Use Permit and Historic Preservation Permit proposing the demolition of a fire-damaged church and rectory and removal of four ordinance sized trees and nineteen non-ordinance sized trees, and allow the construction of an approximately 20,000-square foot church/religious assembly, two-story parking structure, an approximately 15,000-square foot multi-purpose building, expansion of an existing private school (St. Patrick School) without enrollment increase, an off-site parking arrangement for up to 75 spaces, and incidental uses including daycare, private instruction (night classes), caterer, church offices, and funeral services (Project File Nos. SP15-004 and HP15-001).
