**NOTICE OF
COMMUNITY AND PUBLIC SCOPING MEETING FOR
THE CHARCOT AVENUE EXTENSION PROJECT &
ENVIRONMENTAL IMPACT REPORT**

The Department of Planning, Building and Code Enforcement of the City of San José will hold a Community and Public Scoping Meeting for the proposed project and associated Environmental Impact Report (EIR). The purpose of this meeting is to describe the proposed project, the environmental review process, and to obtain your input on the project and issues you wish to see discussed in the EIR analysis. This Community and EIR Public Scoping Meeting will be held in compliance with the City's Public Outreach Policy (6-30) and the California Environmental Quality Act (CEQA), as amended.

Project Description: File No. PP18-044 – The project proposes to extend Charcot Avenue from its eastern boundary at Paragon Drive, over I-880, to Oakland Road in the North San José area. This is an approximately 0.6-miles long 2-lane extension, and includes an overcrossing of O'Toole Avenue and I-880 that would be approximately 720 feet in length. Sidewalks and Class IV bikeways are proposed along the extension. In addition, the proposed project includes intersection improvements at Charcot Avenue/Paragon Drive, Charcot Avenue/O'Toole Avenue, Charcot Avenue/Silk Wood Lane, and Charcot Avenue/Oakland Road. Along the proposed Charcot Avenue extension, the project would require the installation of retaining walls and relocation of existing utilities as necessary, require additional right-of-way from a number of parcels and easement located along the proposed alignment.

Project Location: Charcot Avenue at I-880.

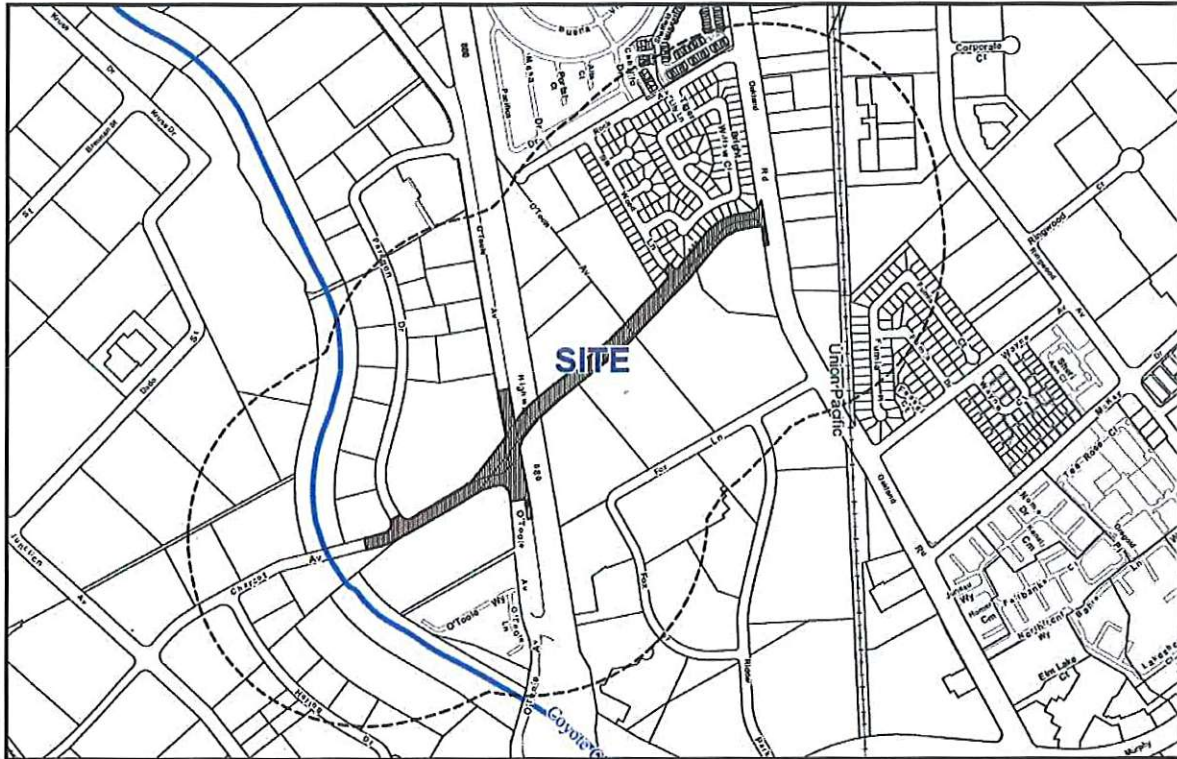
