The presentation will provide an overview of the background information available on the project website: www.diridonsj.org. Information on the Diridon Station Area to be covered includes: the physical context, approved land use plans, future transit improvements, a potential Google development, the City's community engagement process, and a summary of the preliminary Desired Outcomes from engagement to date.

III. Small group discussions

Following the presentation will be small group discussions facilitated by City staff and consultants, as well as Somos Fuertes Promotoras for the September 25th meeting. The purpose of the discussions is to gather feedback on the preliminary Desired Outcomes, based on the input received throughout the engagement process to date. The Desired Outcomes are vision statements, organized by topic: Land Use, Housing, Jobs/Education/Economic Development, Public Spaces, Creeks/Trails, Transportation,

Transit, Parking, and Design. Most outcomes apply to development of the Diridon Station Area, while some of the housing and jobs/education outcomes are intended to apply citywide. The focus is on a potential Google development, but input will also inform other projects related to the Diridon Station Area and citywide issues.
