# IV. Diridon Integrated Station Concept Plan

The City of San José, VTA, Caltrain, and High Speed Rail have launched a collaborative effort to develop a Concept Plan for the reconfiguration of Diridon Station to effectively integrate existing and future transit services. The first phase of this planning process is beginning this fall and will go through summer 2019. The City Council has directed staff to conduct a public outreach and engagement effort as part of the process.

For this agenda item, staff will provide an overview of the Diridon Integrated Station Concept Plan, including the scope, purpose, consultant team, and decision-making process. The presentation will also cover the Draft Outreach Strategy for the Concept Plan process. The SAAG will have opportunity to ask questions and provide feedback.
