SAVE HARMLESS AND INDEMNIFICATION AGREEMENT

CONTRACTOR agrees to defend, indemnify and hold harmless City, its officers, agents and employees (collectively referred to hereinafter as "City") from and against any and all claims, demands, causes of action, or liabilities incurred by City arising, in whole or in part, directly or indirectly, from Contractor's acts or omissions under this Agreement or any act of omission of Contractor's officers, agents, employees, contractors, or persons attending the Meeting or Event with the express or implied permission or invitation of Contractor, except as may arise from the gross negligence or willful misconduct of City. In any action or claim against City in which Applicant is defending City, City shall have the right to approve legal counsel providing City's defense and such approval shall not be unreasonably withheld. Contractor further agrees to release City from any and all claims for any damages, including property damage, injury or death occurring or arising out of use of City's property, except as may be caused by the City's gross negligence or willful misconduct. Contractor agrees to abide by the Facility Use Rules and Regulations and acknowledges having received a copy thereof. Further, Applicant will be held financially responsible for any damage to the Facility or equipment, which occurs through Contractor's Meeting or Event at the Facility. Furthermore, Contractor has reviewed and agrees to abide by the City of San José rules and regulations pertaining to the use of the facility. Contractor understands further that Contractor will be held financially responsible for any damages to facilities or equipment that occurs through the use of the Facility.
