Track Meet Information

Track events take first priority while field events will continue as long as necessary. All participants in track events are competing against the clock in all elimination heats.

1. All participants must provide documentation of birth date prior to competition at Nor Cal State level.
2. All participants must compete in the proper age group.
3. All participants must wear shoes during their event. TRACK SHOES MADE WITH SPIKES ARE NOT PERMITTED, EVEN IF SPIKES ARE REMOVED. HARD CLEATED SHOES AND STARTING BLOCKS ARE NOT PERMITTED AT ANY LEVEL OF THE HERSHEY NATIONAL TRACK AND FIELD YOUTH PROGRAM.

Day of Meet Registration

Registration will begin at 8:00 a.m. All participants who are not pre-registered must register between 8:00 a.m. - 9:30 a.m., the morning of the event.

Pre-Registration

To insure that your child will compete in our meet, we request that you pre-register them by sending in the registration form. There will be registration on the day of the meet. However to avoid confusion and the possibility of your child not participating in any of the events, please pre-register.
