This includes school dress code. **ABSOLUTELY NO RED OR BLUE ATTIRE OR EXPLICIT COSTUMES.** Under staff discretion parents may be notified to pick up his/her child from the dance for not following the rules and regulations.

Tickets for the dance will cost \$6.00 for all CYC Members and for tickets bought before or on Thursday October 29, 2009. Tickets bought on Friday October 30, 2009 or at the door will cost \$8. **Tickets will go on sale Monday, September 28, 2009 and must be purchased at the Camden Community Center main office, Camden Youth Center, online at www.sanjoseca.gov/prns (Click on browse classes, enter activity number 382.2.1350) or announced lunch visits by CYC Staff at participating middle schools. Tickets will NOT be sold by participating school offices. Students will not be allowed to purchase a ticket without a permission slip and school id.** Parent letter, phone calls and/ or faxes will not be accepted in place of a permission slip.
