



NOTICE OF PUBLIC COMMENT PERIOD AND PUBLIC HEARINGS FOR THE FIRST SUBSTANTIAL AMENDMENT TO THE FISCAL YEAR 2025-2026 ANNUAL ACTION PLAN

THE CITY OF SAN JOSE IS PROPOSING A FIRST SUBSTANTIAL AMENDMENT TO ITS FISCAL YEAR (FY) 2025-2026 ANNUAL ACTION PLAN (AAP). THIS NOTICE PROVIDES THE SCHEDULE OF PUBLIC HEARINGS AND OPPORTUNITIES FOR PUBLIC REVIEW AND COMMENT.

The AAP governs the use of federal funds from the U.S. Department of Housing and Urban Development. The City of San José receives the following formula funds from HUD: Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), HOME Investment Partnerships (HOME), and Housing Opportunities for Persons with AIDS (HOPWA). The proposed First Substantial Amendment would update the City’s approved FY 2025–2026 AAP for these funds.

The First Substantial Amendment to the FY 2025-2026 AAP will be available for public review and comment on the Housing Department’s website from December 4, 2025 through December 18, 2025. Comments may be submitted by phone, mail, or email using the contact information provided below. Community members with limited English proficiency are encouraged to reach out using the language-specific contacts listed.
