Dear Valued Partners,

The Housing Department is pleased to provide notice of the following:

- [A public hearing on Technical Substantial Amendments to the FY 2015-20 Consolidated Plan and the FY 2019-20 Annual Action Plan, and Revision to the Final Draft FY 2020-21 Annual Action Plan](#)

The City Council approved the FY 2020-25 Consolidated Plan and FY 2020-21 Annual Action Plan on August 11, 2020. These Plans incorporated a spending plan for approximately \$32.8 million in Emergency Solutions Grant (ESG) CARES Act funding for homeless housing, hygiene, and outreach. The proposed technical amendments will simply move the spending plan out of the FY 2020-21 Annual Action Plan, and into the City's FY 2019-20 Annual Action Plan and 2015-20 Consolidated Plan, to meet the U.S. Department of Housing and Urban Development's (HUD) requirements.

We welcome public comments on these actions. All public comments will be submitted to HUD. Find the draft Amendments and staff reports by selecting the links above, on the [Housing Department's website](#), or on the [City Council agenda for September 22, 2020](#) under [item 8.2](#).
